NCA CONFERENCE POLICIES

- Please complete all information requested on this form. No person will be considered officially registered for the conference without payment received in full at the time this registration is submitted.
- You may register online or via mail. Please see address and contact information on page one of this form.
- <u>GUESTS.</u> 2014 "Guests" are defined as non-NCA (member) individual (s) who accompany a full-paying 2014 conference attendee to all "Guest Invited" events and activities which are listed as such on the agenda. All guests must be at minimum 21 years old and must be officially registered and paid for in advance no less than six weeks prior to the start date of the conference. No guest fees or registrations will be accepted at the door of a 2014 conference event or activity. The full paying registrant is responsible for the behavior of his or her guest (s) at all times.
- **<u>REFUNDS</u>**. If requested in writing before June 1, 2014 a one-half refund will be issued. Please allow 4-6 weeks from the date of the refund request to receive the amount due in the form of a check made payable to the registrant. Requests for refunds in writing and received after June 1, 2014 will not be honored.
- The National Concierge Association (NCA) is not obligated at any time to transfer unused paid registrations towards the payment of future conferences.
- Paid registrations may be transferred to another attendee in lieu of a transfer at any time prior to July 1, 2014.
- Written requests to transfer and a completed new written registration must be submitted to the Chief Executive Officer in order to be considered officially transferred and registered.
- Room registrations are on a first-come, first-served basis per the NCA reserved block of rooms for this conference. The NCA encourages attendees to register as early as is possible to ensure accommodations at the Downtown Grand Resort.
- In the event the host hotel is on a sell-out status during the registration period, the NCA will make every attempt to
 secure comparable accommodations at another hotel located closest to the host hotel. There may be however additional charges which will be discussed with the attendee who must then agree in writing to pay the NCA for any additional
 charges for either hotel and/or transportation.
- NCA-Nevada Chapter members may register for NCA 2014 Conference "events only" attendance provided the NCA
 member lives and works within 100 miles of Las Vegas, Nevada. NCA-Nevada Chapter member registrations must be
 completed by July 1, 2014.
